Old Business: Kiplinger Foundation Grant Agreement – Carol has received the agreement

from the Tom and Alice Kiplinger Foundation signed by President, Deb Christy. Mid-Plains Community College Rodeo Sponsorship – We have not received a sponsorship request from the Rodeo team although the Visitors Committee did pre-approve the expenditure. Suggestions were made to contact Sherry Stang, a

member of the Booster Club, to see if she can facilitate our sponsorship. Nebraska Junior Match Play Championship – June 22-25, 2021 – Carol talked with Ben Vigil with the Nebraska Golf Association and told him that we would provide Goody Bags in the form of the insulated lunch bag, bottled water, granola bar, coupons from local businesses and brochures. He indicated that if there was a financial sponsorship we could provide, it would be appreciated. Motion was made by **Tyler** and seconded by **Curtis** to approve a sponsorship of \$1000.00 for this event, to be used how the NGA feels is appropriate. Motion carried 3/0.

Director's Report: Birding Challenge – Brochure is available for the Birding Challenge and will be

available at Keystone and distributed at the NETA Brochure Swap in May. No

entry forms have been returned as of this date.

Prairie Chicken Dance Tours - 2021 – The tours have been successful this season with participation from 17 states thus far this year. There is a waiting list for the tours but it is unlikely they will be able to be accommodated this year and will be notified when reservations will be accepted for next year. Carol is in negotiations with groups for 2022 dates already. There are two more tour dates for the 2021 season. **Daniel** congratulated **Carol** on her success.

Kansas Nebraska Heritage Area Partnership – Carol attended the County Commissioners meeting in response to information provided in opposition to the establishment of a National Heritage Area to present the view point of those working towards this designation. Carol has been serving on the Board of Directors of KNHAP and, through her due diligence of the program, does not feel that it would be a detrimental influence on private property rights which is the primary concern of the opposition. The Commissioners thanked her for her input.

Drone Footage Project Dates – **June 4-6, 2021** – Carol has made arrangements with Creative Olson to come the weekend of June 4-6, 2021 to do the photography described in our grant application that was awarded by the Nebraska Tourism Commission. These dates coincide with the Pro Am and a reining horse competition at the Kiplinger Arena. Carol has contacted all parties involved and received their agreement in having the photographers at their events.

Southwest Nebraska Playbook – This is a situation where **Carol** is asking for forgiveness rather than permission. She authorized a ½ page ad in the 2021 Southwest Nebraska Playbook in the amount of \$350. The ad will be promoting the Birding Challenge. **Carol** distributed a copy of the ad.

The Travel Guide with be available in a digital form with generates 130 million impressions daily with 10 million travelers throughout the Midwest states of Michigan, Missouri, Ohio, Nebraska, Illinois, Kansas, Minnesota, Indiana, Iowa, North Dakota and South Dakota receiving an email with a copy of the digital edition. 100,000 print copies will also be distributed throughout the Midwest. Based on the distribution and other participation from Nebraska communities, **Carol** recommends that we purchase a ¼ page ad with the cost of \$1,500.00.
