**Director's Report:** 2024 Nebraska Passport Program – Carol reported that the Nebraska Tourism

Commission has opened the applications for the 2024 Passport Program. She will be discussing with the High Plains Historical Society about increasing their hours during next summer with the possibility of working from the Museum to help with that. She also encouraged the Committee to provide her with names of any business that should be approached to apply so that we get more submissions

from this corner of the state.

**Travel** + **Leisure Article** – Carol reported that McCook was named runner up as Best Small Town in America in the Food and Arts category. This came about because we were nominated by a member of Miles Partnership, ad agency for the Nebraska Tourism Commission, that was here last Spring for a Prairie Chicken media tour. While the write-up for Travel + Leisure was a short blurb, the freelance writer left with a dozen other story ideas she plans to pitch to other magazines she contributes to.
